## FOREWORD

1. The procedure was developed by a working group.

2. It is approved by the rector of KSMA.

3. It comes into effect upon approval.

4. Periodic review of the Procedure is conducted at intervals not exceeding 12 months.

5. Changes to the Procedure are made based on the results of its application at KSMA or when there are changes in the requirements of regulatory documents upon which the Procedure was developed.

### **1. PURPOSE**

1.1. The Quality Management System Procedure (hereinafter referred to as the Procedure) establishes general provisions, the sequence, and methodology for assessing the satisfaction levels of staff, students (including foreign ones) and stakeholders regarding the quality of education and the educational process.

1.2. Confidentiality. This procedure is an internal regulatory document of KSMA and is not subject to disclosure to other parties except auditors of KSMA or auditors of the certification body during quality audits.

## 2. FIELD OF APPLICATION

The requirements of the procedure are mandatory for implementation by those responsible for conducting satisfaction assessment among customers.

### **3. NORMATIVE REFERENCES**

This Documented Procedure has been developed in accordance with the requirements of the following regulatory documents:

## 4. TERMS, DEFINITIONS AND ABBREVIATIONS

The following definitions are used in this Procedure:

Survey question	a message directly addressed to respondents, as well as proposed answer options, aimed at a single characteristic, process, fact, or phenomenon.
Survey	a research method involving respondents independently completing a questionnaire.
Survey form	a unified system of questions aimed at identifying quantitative and qualitative characteristics of the research object.
Data	primary information obtained as a result of the research.
Surveyor	a person conducting the research.
Tasks	specific measures to achieve the set goal.
Research tools	a set of technical procedures related to the chosen research method, including private operations, their sequence, and interrelation.
Purpose	a model of the expected final result (problem-solving) that can only be achieved through conducting the research.
<b>Research method</b>	the main method of data collection, processing, and analysis.
Questioning	a method of obtaining data based on direct or indirect communication between the researcher and the respondent to obtain necessary data in the form of responses to posed questions.
Research problem	scientific reflection of a problematic situation formulated as the need for the development of practical actions aimed at identifying the causes that trigger it.
Problematic situation	a phenomenon characterized by a discrepancy between functioning and the development needs of the academy.

Stakeholder(s)	stakeholders, both individuals and legal entities, who have a legitimate interest in the organization's activities, meaning they are to some extent dependent on it or can influence its activities.

## 5. ORGANIZATION AND SURVEY PROCEDURE FOR PARTICIPANTS OF THE EDUCATIONAL PROCESS AND STAKEHOLDERS

5.1. Researches are conducted at KSMA to assess the satisfaction of internal customers with the quality of services provided.

5.2. Satisfaction surveys for each category of customers are conducted not less than once a year. The timing of the next survey is determined by a separate order of the academy's rector.

5.3. The research includes the following stages:

- development of the research programme;
- field data collection;
- mathematical and statistical processing of the collected data.

Note: The research stages should be interconnected and maintain continuity.

5.4. Development of the research programme.

## 5.4.1. Objectives of developing the research programme.

The development of the research programme is carried out with the aim of:

- •clear understanding of the problem, objectives, tasks, object, and subject of the research;
  - •determination of the composition and sequence of research stages;

•ensuring a system of division of labour among members of the research team;

•effective analysis of the collected data.

## 5.4.2. Contents of the research programme.

The research programme includes the following sections:

- •information collection;
- •analysis of research data;
- •report on the results of the conducted research.

## 5.4.3. Research problem

The research problem is formulated based on the problematic situation. The problematic situation may arise from the deadline for the next survey, a request for research from an educational structure of the academy, or the identification of a phenomenon characterized by a discrepancy between the functioning of the academy and the needs of its further development.

## 5.4.4. Research purpose and tasks

5.4.4.1. The purpose of the survey is to determine the opinions of representative groups of participants in the educational process and stakeholders regarding the quality of education and the educational process at KSMA, establishing feedback between participants of the educational process and stakeholders for its continuous improvement.

5.4.4.2. The purpose of the research may include:

• gathering descriptive (statistical) information about the quality of educational services provided at KSMA;

• analyzing the reasons for the occurrence of problematic situation.

5.4.4.3. The research tasks represent a substantive, methodological, and organizational specification of the purpose:

• conducting independent, systematic surveys of participants in the educational process and stakeholders regarding the quality of education and the educational process at KSMA;

• based on the survey results of participants in the educational process and stakeholders, forming proposals for improving the educational process and study programmes;

- preparation of analytical reports based on the survey results;
- compiling rankings of educational components, teaching staff, etc;
- identifying strengths and weaknesses of the educational process at KSMA.

5.4.4.4. Based on the research tasks, programmatic questions are developed. One task may contain several programmatic questions. Together, these questions cover all aspects of the research programme.

## 5.4.5. The research plan

The research plan is developed based on the research tasks and is reflected in the directive issued by the academy's rector regarding the conduct of the research.

It may include:

• research stages with specified deadlines, method (offline or with using online resources), and responsible parties for their implementation;

- data about ensuring proper conditions for conducting the research;
- staffing provision for the research;
- method of reproducing research tools;

• software products necessary for mathematical and statistical processing of collected data.

## 5.4.6. Object and subject of research

5.4.6.1. The object of the research is the carriers of the problematic situation that will be examined using the developed tools. The selection of the object is based on the analysis of the research problem. The same object can be studied to address different issues and can involve numerous subjects of research.

5.4.6.2. The subject of research includes the properties of the research object that most fully express the investigated problem.

5.4.6.3. The survey groups include:

- students;
- teaching staff;
- employers / stakeholders;

- graduates from different years;
- applicants;
- applicants' and students' parents;
- local government bodies;
- other interested parties.

# 5.4.7. Directions for questioning participants in the educational process and stakeholders:

- quality of education at the Kherson State Maritime Academy overall;
- quality of study curriculum and work plans;
- quality of study programmes;
- quality of educational components;
- quality of teaching specific educational components;
- level of satisfaction with the organization of the educational process, methodological and material and technical facilities at KSMA;
- level of satisfaction with the educational services received;
- adherence to the principles of student-centered learning;
- adherence to the principles of academic integrity;
- competitive advantages of KSMA;
- relevance of the content of study programmes to the needs and requirements of the labor market;
- objectivity and transparency of the assessment system;
- other tasks.

## 5.4.8. Methods of information collection

5.4.8.1. The choice of information collection method is made based on the research tasks.

The most common (but not the only) method of information collection among customers is questioning.

The main types of questioning are paper-based and electronic surveys on the LMS Moodle platform. (Survey forms for foreign students are conducted in English).

To improve the teaching of educational components, questionings of cadets are planned on the LMS Moodle platform upon completion of studying each component.

5.4.8.2. The research programme describes the selected method of sociological research and indicates its organizational features.

## 5.4.9. Research tools

5.4.9.1. The research tool for assessing the satisfaction of customers of HEIs is a survey form addressed to a specific object. The survey form can be presented in both paper and electronic form on the Internet, depending on how the research is conducted.

5.4.9.2. The survey form consists of the following blocks:introductory block;

- •informative block;
- concluding block.

5.4.9.3. The introductory block is located at the beginning of the survey form. It may include greetings to the respondents, a brief overview of the survey, which includes:

- the name of the organization conducting the research;
- the purpose of the research;
- brief instructions on how to fill out the survey form;
- reminder about the confidentiality of the research.

5.4.9.4. In the informative block, each formulated research question is translated into a set of survey questions. The composition of questions in the informative block in the survey form is determined by the research tasks, the questioning topic, and the specific characteristics of the questions.

5.4.9.5. The concluding block is located at the end of the survey form. It contains a thankful message to the respondent for participating in the research, and if necessary, space for the respondent to write comments or suggestions.

5.4.9.6. Formulating a survey question consists of two parts:

the questioning part, which contains information already known to the surveyor;
the response part, which contains the missing information.

5.4.9.7. When formulating questions, it's necessary to adhere to the following requirements:

- the information in the questioning part should be known and equally understandable to both the surveyor and the respondent;
- the questioning part should not contain explicit or implicit expectations from the surveyor regarding possible respondent answers;
- only one option should be indicated in the response part of the question;
- providing the respondent with the option to abstain from answering is necessary;
- maintaining logical coherence between the questioning part and the answers to the question;
- questions should precisely measure the phenomenon under research;
- clearly indicating the question recipient;
- •questions should be asked in a respectful manner, using the address "You" is recommended;
- question formulations should not push the respondent towards choosing a particular response option;
- questions should be arranged in a way that the question formulation and response options are simultaneously visible to the person answering them;

• questions should not contain terms that are unclear to the respondent.

5.4.9.8. The survey form may contain the following types of questions:

- open-ended;
- closed-ended;

• filter questions;

• matrix questions.

5.4.9.9. Open-ended questions, after stating the question, contain the word "Insert" and provide sufficient space for the respondent to write their answer.

5.4.9.10. Closed-ended questions contain a list of all possible answer options. It is recommended to include an "Other" option in the list of possible answers with space for the respondent to enter their own answer.

5.4.9.11. Filter questions are used for clear segregation of questions among respondents. They contain:

- a question addressed to all respondents;
- a list of answer options;
- instructions "Move to question #" placed next to the necessary answer options;
- compounds between answer options and instructions for moving indicated by arrows.

5.4.9.12. Tabular format is used for questions that have similar answer options for the convenience of further data processing, saving respondent time, and compactness of the survey form. They contain:

- formulation of the question;
- indication of the possible number of responses in each row or column;
- table, where typically answer options are placed in rows, and question objects are placed in columns.

5.4.9.13. The developed tools are appended to the Research Programme as a separate document.

5.4.9.14. According to the initiative of the guarantors of the SP/EP and the leadership of the KSMA, aimed at systematic improvement of teaching quality, the Education Quality Management Department is initiating a questioning among students to collect objective information regarding the quality of teaching in a specific educational component, using the Survey form for Students on Teaching Quality at KSMA, appendix 1.

5.4.9.15. The survey form for students regarding distance learning at KSMA is provided in appendix 2.

5.4.9.16. The survey form regarding the employment of graduates is provided in appendix 3.

5.4.9.17. The form survey for the stakeholder on the quality of educational services provided by Kherson State Maritime Academy is presented in appendix 4.

5.4.9.18. The form survey for the study of teachers' satisfaction with their professional activity is presented in appendix 5.

5.4.9.19. The form survey "Survey of Postgraduate Students' Opinions on the Quality of Postgraduate Training at KSMA" is presented in appendix 6.

5.7.5. Based on the report results, a plan to eliminate deficiencies is developed, which is reviewed by the Academic Council of KSMA and put into effect by the order of the Rector of the academy.

## 6. FINAL PROVISIONS

6.1. Responsibility for the issuance, updating and cancellation of this Procedure lies with the responsible persons in accordance with the SE "Documentation Management".

6.2. The procedure comes into force from the moment of its approval by the Rector and implementation by the Rector's order.

6.3. Amendments and additions to the Procedure shall be made by setting it out in a new version.

6.4. Control over compliance with the requirements of this Procedure shall be exercised by officials in accordance with their functional responsibilities.
